



**Construction Engineering and Inspection Services
Solicitation No. 19-117– Addendum #2

This Addendum #2 to SRTA Solicitation No. 19-117 is being issued in accordance with Section 2.5 of the Request for Proposal document. SRTA Solicitation No. 19-117 is hereby amended as follows:

PART 1-Solicitation, Offer, and Award

Part 1-Solicitation, Offer and Award is hereby deleted in its entirety and replaced as follows. For the convenience of the submitting firms, an overview of the major changes has been provided below. *Proposers are advised to read the Revised Part 1-Solicitation, Offer & Award, attached hereto, **in its entirety**.* The overview provided does not in any way absolve a submitting firm of its obligation to read the solicitation, in its entirety, prior to making a Qualifications Submission.

- **Section 3.1-Organization of the Statement of Qualifications Submission** has been deleted in its entirety and replaced as attached hereto in Part 1-Solicitation, Offer & Award of this RFQ. The section has been revised to clarify the number of Offer Documents and contents of a complete Qualifications Submission.
- **Section 3.1.3-Mandatory Requirements** is hereby deleted in its entirety and addressed in Offer Document #6-Mandatory Requirements Response Form.
- **Section 3.1.4.-Statement of Qualifications** has been renumbered as Section 3.1.3. In addition, this Section has been revised to include subsection (a)-Firm’s Expertise and Experience and clarify certain requirements regarding subsections (b) through (f). Project management experience shall not be required for Team Leaders or team members.
- **Section 4.0-Mandatory Requirements** is hereby deleted in its entirety and addressed in Offer Document #6-Mandatory Requirements Response Form. All subsequent sections have been renumbered based on this deletion.

PART 2-Scope of Services

- **Section III (B)-Testing and Inspection** has been revised to identify the types of certifications required for any labs performing tests under the resulting Contract.
- **Section III(C)-Personnel** has been revised to identify the required certifications for the Inspector and Materials Tester.
