

SRTA Solicitation 23-000: Toll Integration Service Contractor

The State Road and Tollway Authority (SRTA) is seeking qualified contractors interested in serving as SRTA's Toll Integration Service Contractor (TISC) to replace and maintain the all-Electronic Toll Collection Systems (ETCS) for SRTA's existing four operational Express Lane facilities: the I-75 South Metro Express Lanes, the I-75/I-575 Northwest Corridor Express Lanes, the I-85 Express Lanes and the I-85 Express Lanes Extension.

SRTA anticipates the release of the Request for Qualifications (RFQ) in the first half of 2023.

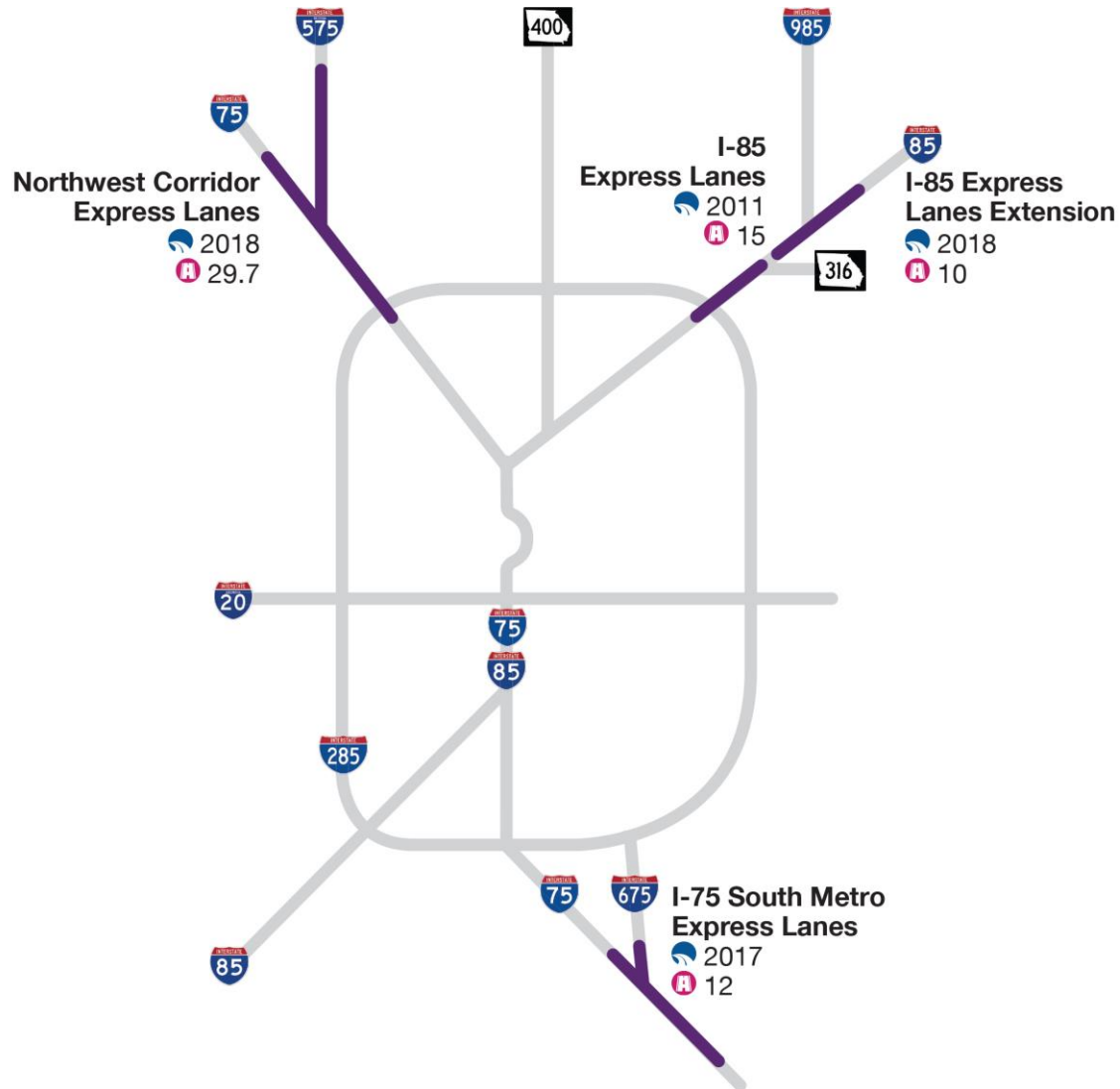
